We train and support our members

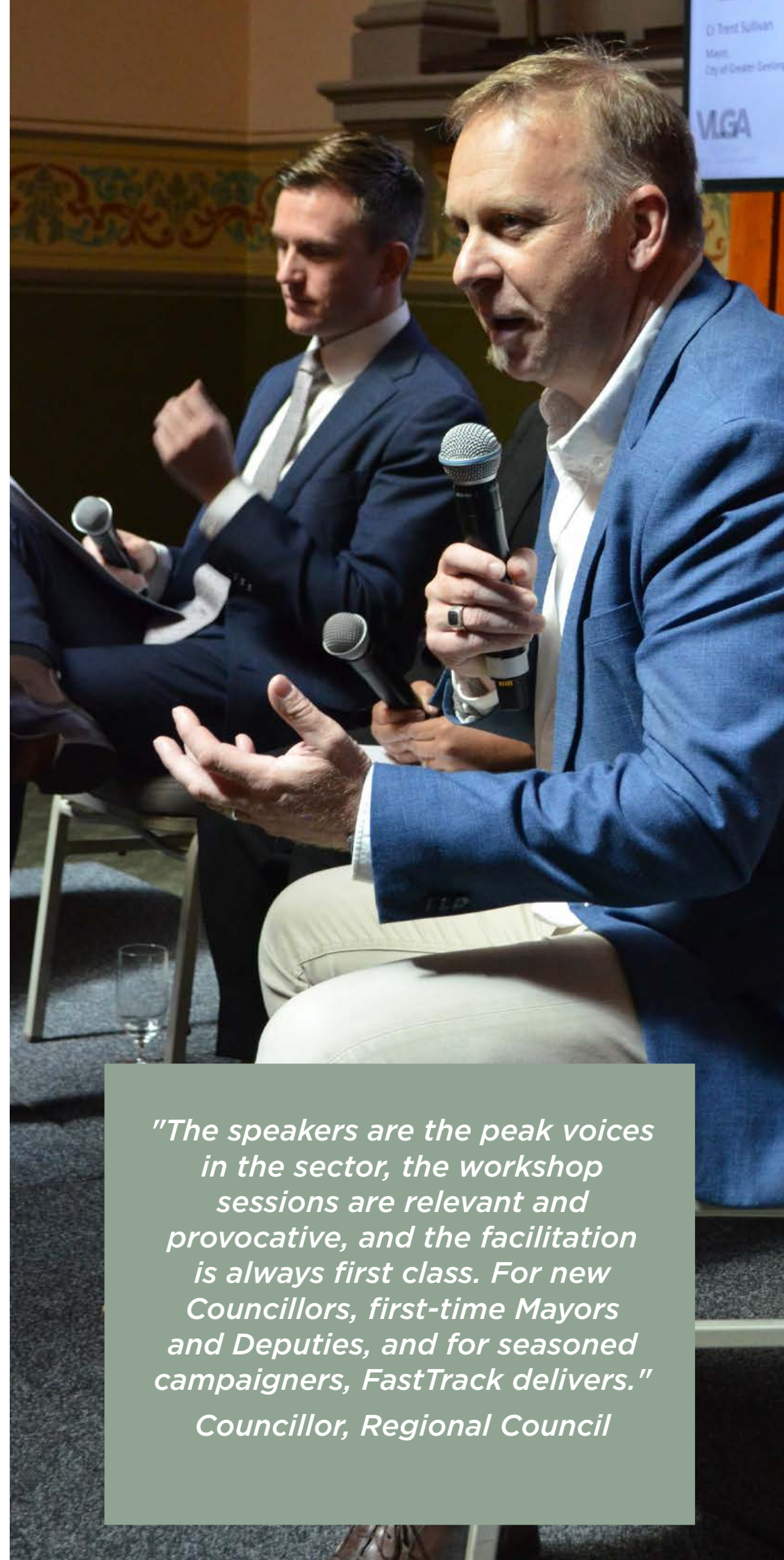

The VLGA event program ranges from small, targeted online workshops through to live forums that push the boundaries of local government thinking. Most VLGA events are offered in either hybrid or online formats – enabling members from across Victoria to participate without the need to travel outside of your municipality.

The VLGA also offers a diverse suite of training and professional development programs specifically designed for councillors and councils.

All training is strongly aligned with the new mandatory training requirements set out in the *Local Government Act 2020*.

As a VLGA member, you will enjoy discounted prices on our sector-leading training programs. Through our program of ongoing professional development workshops and seminars, our members are armed with the knowledge and skills to perform at their best and with good governance as their foundation.

Lunch & Learn Sessions

Throughout the year, your VLGA provides access to free exclusive professional development Lunch and Learn sessions.

Session topics address key issues impacting our members, and discussions are led by subject matter experts from across the local government sector.

These online workshops are an invaluable opportunity for you to build your critical thinking skills, share reflections within a confidential forum and work together with your fellow VLGA members to develop experience-led solutions.

What we've done

Our FastTrack Professional Development Program is an intensive one-day program designed to give councillors the tools and strategies they need to serve the community well, as well as the opportunity to network with and learn from their peers and industry leaders.

FastTrack has been called one of the most engaging professional development opportunities on the councillor calendar.

VLGA is a champion for local government

We advocate for and represent our members

The VLGA has a front row seat to Ministerial decisions and discussions impacting the local government sector.

As a VLGA member, your experiences inform our engagement and dialogue with government, directly helping to shape the agenda and future of the local government sector.

Your VLGA works in partnership with other sector organisations, providing a united voice to government on issues that directly affect local councils.

We are an active participant in all discussions regarding the implementation of government policy as it impacts across our sector, and represent your voices across key working groups, committees and reference groups, as well as within our submissions and discussion papers.



Did you know?

At the local government elections in 2020, the VLGA launched our *Tap Her On the Shoulder Campaign* to encourage women to stand for local government. Our goal was to support gender parity across all Victorian councils. As a result of our advocacy, a record number of women councillors were elected by their communities.

Our commitment to encouraging more women to become councillors has continued during the most recent election campaign with the number of women being elected as councillors growing by 15.

The average number of women councillors at member councils is currently sitting at 46%, compared to 38% at non-VLGA member councils.

Member Exclusive Governance Advisory Network

As a VLGA member, you can join our Governance Advisory Network (GAN). The GAN provides councillors and governance professionals access to critical information and resources to support their good governance, including updates on the latest in governmental policy developments and changes and issues impacting the local government sector, as a whole.

The GAN also acts as a key information channel with your VLGA, where the lived and living experiences of our members inform our political advocacy on necessary legislative and policy change.

We believe good governance is best served through diverse voices participating in decision-making.

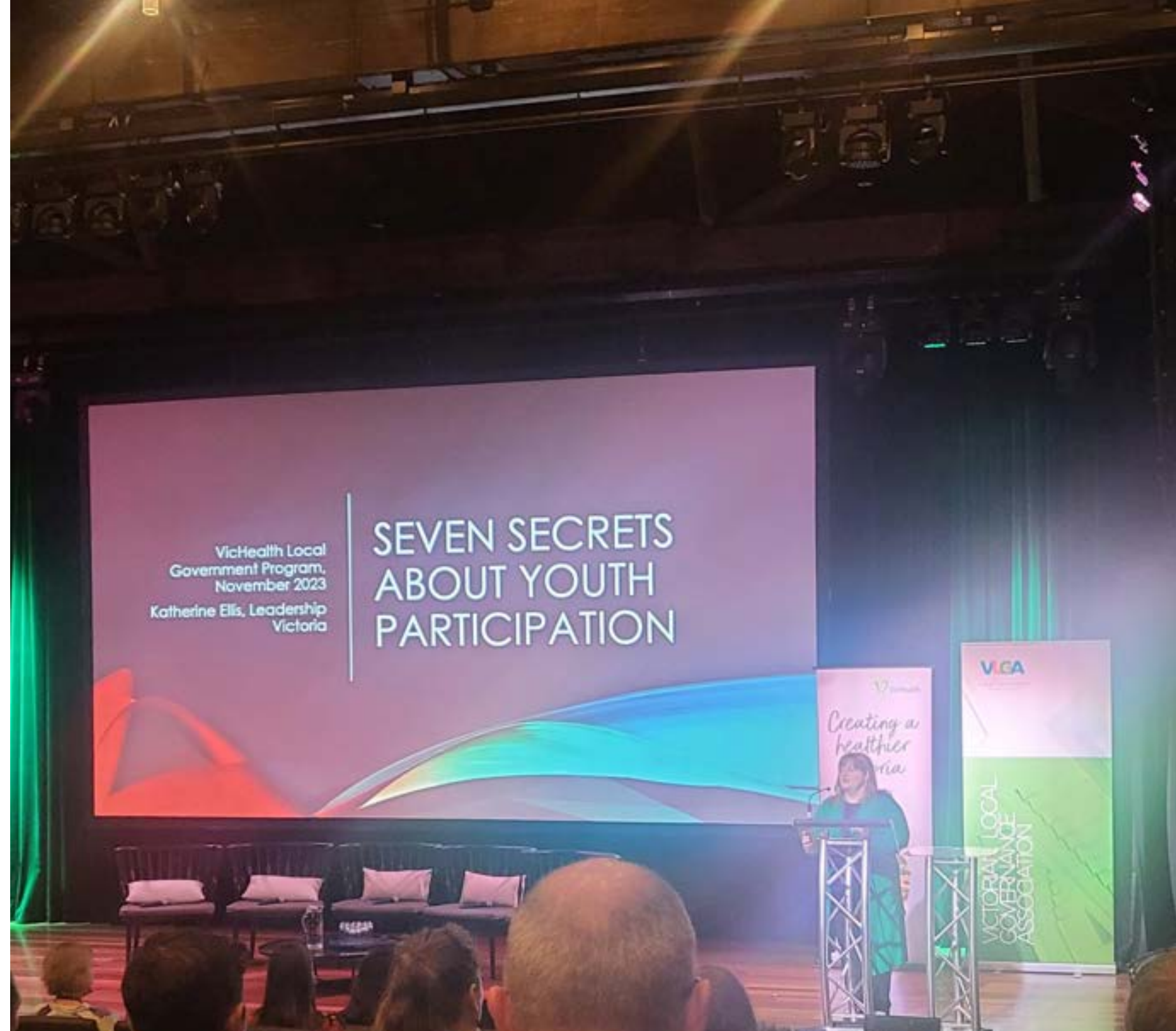
The VLGA works with councils and local communities on programs which directly affect the health and wellbeing of their municipality.

We have worked in partnership with a range of councils on key issues impacting their communities, including programs focussed on harm prevention from gambling as well as health education and prevention.

In reflection of the VLGA's ongoing commitment to achieving gender equality across Victorian councils and

championing diverse voices, we offer tailored training programs that recognise the unique experiences and gendered challenges experienced by women councillors.

Our Local Women Leading Change content offers practical solutions for women councillors, that is grounded in lived experience. This work is based on research results derived from our ongoing industry partnership with LaTrobe and Melbourne Universities.
